Whereas, the courts in the Criminal and the Family Court Divisions cannot operate without adequate security, and

Whereas, it is in the best interest of the County for the courts to expedite cases in as timely a manner as possible,

Now, therefore be it resolved by the Jefferson County Commission that the President is hereby authorized to execute on behalf of the County an agreement with the A.O.C. to provide reimbursement to the A.O.C. for employment costs for said bailiffs in the Birmingham and Bessemer Divisions of the Tenth Judicial Circuit not to exceed the maximum amount of \$826,949.74 appropriation for fiscal year 2012-2013.
